I, the undersigned, acknowledge and agree to the following terms and conditions as a client of *The Gibsons Dogrunner (Krisztina Harasztosi*), mentioned as *TGD* 

- 1. *Assumption of Risk*: I acknowledge that dog training, dog walking and behavior modification may involve risks, including but not limited to, the risk of injury to myself, my dog(s), and others. I assume all risks associated with my participation in these activities.
- 2. *Behavior Disclosure*: I agree to disclose any known behavior issues or history of aggression that my dog may have. I understand that failure to disclose such information may result in termination of services.
- 3. *Safety Requirements:* I understand and agree to adhere to all safety requirements in case my dog shows potential aggressive behavior and/or he/she is a bite risk. I acknowledge that not following these requirements may result in the trainer leaving the property or training area.
- 4. *Property Damage:* I acknowledge that I am responsible for any damage caused by my dog to property or persons during training sessions or consultations.
- 5. *Photographs and Media:* I grant permission for TGD to use photographs and videos of my dog for online promotional and educational purposes. I understand that no personal information will be disclosed.
- 6. *Payment:* I agree to pay for all sessions in full before the first session. I understand that this payment is required to secure my spot in the training program.
- Cancellation Policy: I understand that I must provide at least 24 hours' notice for weekday cancellations and at least 72 hours' notice for weekend cancellations. Failure to provide the required notice will result in the loss of one session.
- 8. *Package Expiry*: If I start a training package and stop the training for more than 4 weeks without notice, my package will expire. If I have more than three remaining



sessions at the time of expiry, I am eligible for an assessment session and a training plan update.

- 9. *Service Limitation*: I understand that TGD will do her best to keep my dog safe and happy, but she is not responsible for any unpredictable events, including but not limited to my dog running away, encountering wildlife, or injuring another person or animal.
- 10. *No Guarantees:* I acknowledge that no guarantees can be given regarding the results or the time needed to achieve them, as these depend on various factors including my dog's temperament, age, previous training, health issues, and the time and quality of training I do and the way I follow instructions.
- 11. *Waiver of Release and Indemnification:* I release, waive, discharge, indemnify, and agree to hold The Gibsons Dogrunner (Krisztina Harasztosi), its owners, directors, officers, employees, and agents harmless from any and all manner of damages, injury, claims, loss, liabilities, costs or expenses, attorney's fees, causes of action or suit, arising out of or related to the services provided, including my dog's and my behavior.
